D. H. Jutzi Limited

D. H. Jutzi Limited is composed of three divisions. The Fuels, Lubricants and Solvents Division is managed by David E. Jutzi Jr. Fuel is supplied to farms and commercial accounts along with heating oil to the residential market. Gasoline in regular and premium grades along with ethanol blends are supplied to the automotive market, coloured diesel fuel to off road equipment and clear diesel to road maintenance and trucking industries. A large inventory of automotive and industrial lubricants, including synthetics, complements our product line. Most of the customers are within a 50 km radius of our office. This division has provided quality petroleum products since 1953.

The Water Treatment Division created in 1982 is managed by Brian Jutzi, CWT. This division serves its clients with Water Treatment products for prevention of scale and corrosion in steam boilers, open recirculating cooling tower systems, closed loop and glycol systems. It also supplies and installs commercial water softening equipment and reverse osmosis systems to industries that require high quality water in their processes. A complete line of waste water treatment products and services are also provided. For example, many industrial manufacturing plants must remove impurities from their waste water before discharging to the sanitary system. A complete line of residential water softeners and drinking water filters are sold and serviced. The area serviced is from Mount Forest to Chatham. This division is currently in the process of obtaining ISO 9002 registration.

The Heating and Air Conditioning Division, established over 30 years ago, is overseen by D. H. Jutzi Sr. with Wayne Lamb as Service Manager. A full line of heating equipment including, warm air, hot water boilers, radiant in floor heating, and domestic hot water heaters are sold and serviced. While they specialize in oil heating, licensed technicians are available to install and service gas equipment as well. The service department provides installations for the Water Division and installs and services equipment for our gas and diesel customers, as well as maintenance and repairs to the gas bar and cardlocks for Jutzi Petroleum Inc.

The Jutzi Petroleum Inc. retail gas bar and commercial cardlocks are managed by David E. Jutzi Jr. This company also sells petroleum products to retail service stations, with the product deliveries made with D. H. Jutzi Limited equipment. The commercial cardlocks, featuring gasoline and diesel pumps, are accessed by customers on a 24 hour basis with proprietary cards. Our cardlock locations are Woodstock Street North, Tavistock and 279 Lorne Ave., Stratford, and are accessible to vehicles of all sizes, includ-

ing large trucks.

Jutzi Holdings Inc. provides administrative and asset management services for all companies with Dean Jutzi, C.A. as Treasurer, and Frieda Jutzi as Office Manager.

Since our beginning in 1953 it has been our policy to provide high quality petroleum products, water treatment supplies, and home heating equipment, with a combination of service and expertise unmatched elsewhere. We have been privileged to have served three generations in many families.
